Activity Risk Assessment

Water Jumps

Location: Sunderland Marina and Harbor, Tidal River Wear
 Any areas outside of this need a site specific risk assessment and management approval

Hazard	Potential harm	To Whom	Control Measures
Jumping from Height	Personal injury / drowning	Staff and participants	<p>Instructors discretion on how many participants can jump in at a time, this is determined by weather, the group's ability and location.</p> <p>Participants can jump together but must be at least be an arm's length away, participants must NOT hold onto each other while jumping.</p> <p>Weaker swimmers/ jumpers are advised to start off at lower heights and build their way up.</p> <p>Instructor MUST always bring a throw line and participants informed on the use. Instructors discretion on whether they should take a paddle or sling to assist swimmers in the water.</p> <p>Participants must NOT jump until the instructor states it's safe to do so.</p>
Fall from Height	Personal injury	Staff and participants	When not participating in the jumping activity all must keep 2m from the take off edge or be behind a physical barrier.
Poor landing / Encountering bankside	Personal injury / drowning	Staff and participants	Staff to ensure participants clear the takeoff area with spotting / guiding of the jumper if needed.
Front Flips / Diving	Personal injury	Staff and participants	<p>Staff discretion to the group's ability. Should the instructor allow the group to do flips it will only be front flips, backflips are not advised.</p> <p>The highest point the participants can flip from is the head height of the individual jumping.</p>

			<p>Diving is permitted from <1m (the height of the wave brake)</p> <p>Participants with recent previous injury are advised not to flip or dive</p> <p>Instructor to make sure the area is clear of debris/ other participants in the water.</p>
Bottoming Out	Personal injury / drowning	Staff and participants	<p>Staff to ensure the landing area is of sufficient depth for the height of jump and size of group.</p>
Entanglement	Personal injury / drowning	Staff and participants	<p>Staff to ensure the landing area and surroundings are free from underwater obstructions and debris.</p> <ul style="list-style-type: none"> Instructor to always carry a knife.
Cold Water Shock	Drowning	Staff and participants	<p>In very low temperature conditions (water temp less than approx. 10C) ensure participants are acclimatised by partial immersion before jumping.</p> <p>In cold conditions staff to brief participants to breath out / shout etc on landing.</p>
Slips, trips, falls	Personal injury, hypothermia, drowning	Staff and participants	<p>Be extra careful on the marina walkways following periods of rain or if there has been an overnight frost.</p> <p>Ensure that none of the participants run on the walkways or jumping area.</p> <p>Staff to brief participants on potential hazards such as glass, seaweed and discarded rope and strategies to avoid hazards.</p>
Water	Hypothermia, drowning	Staff and participants	<p>Staff to control numbers of participants in the water at any one time such that all participants can be accounted for at all times.</p> <p>Non swimmers to be identified and closely monitored at all times.</p> <p>No gum/food to be consumed when jumping.</p> <p>Correctly fitted BA's and helmets to be worn at all times.</p> <ul style="list-style-type: none"> Staff to carry throwline at all times.
Effects of weather	Hypothermia, Hyperthermia, Sunburn	Staff and participants	<p>Weather forecast obtained before activity, weather forecast posted on notice board in office.</p> <p>Visual inspection of weather conditions before the activity commences.</p> <p>Abandon if weather deteriorates.</p> <p>Ensure adequate warm and protective clothing for the prevailing weather.</p> <p>Advice all involved to use sun cream during sunny weather.</p>

Activity Risk Assessment

			<p>Take rest breaks in hot weather.</p> <p>Use activity to keep participants warm in cold weather.</p> <p>Use group shelter to provide a temporary respite.</p>
Person under the influence of drugs / alcohol	Personal injury	Staff and participants	<p>Staff to exclude anyone who is apparently under the influence of alcohol or drugs.</p> <p>Tests or physical proof is not required, the instructors decision is final.</p>
Water quality	Disease, illness	Staff and participants	<p>Ensure all staff and participants wash their hands before either drinking or eating.</p> <p>Emphasize good personal hygiene.</p> <p>Cover all cuts and grazes with waterproof dressings.</p> <p>If the area of operation is particularly heavily contaminated with oil or debris then staff member should consider modifying the session or relocating.</p>
Stings and cuts	Personal injury	Staff and participants	<p>Instructor to ensure that all participants are wearing robust footwear and arms legs are covered in periods of weather conditions where jelly fish may be encountered.</p>
Transmission of COVID	COVID Infection	Staff and participants	<p>Instructor will implement and ensure safety measures are in place which are in-line with the latest government advise (see COVID OP's for details)</p>

Risk assessments are to be reviewed on an annual basis unless an incident occurs, which then dictates immediate review of the risk assessment.
